Total Marks {Technical Criteria (80) + Financial (20)}: 100

After getting the financial score from the remaining **20** marks, the two scores will be combined to indentify the heights ranking firm.

Merit Point Evaluation Methodology: Contract will be awarded to the lowest evaluated responsive firm which gets the maximum marks and becomes the **highest ranking** in the Combined Evaluation calculated through the Merit Point Average Methodology which puts greater emphasis on non-price factors like stringent global certifications on Conformance Specifications (i.e meeting the required technical specifications), performance Specification (i.e meeting the requirements the product is designed for) leading to customer satisfaction verification, certifications of the technical staff, provision of maintenance & services, provision of training on equipment ad post-warranty services etc. the following weight-ages will be given to the technical scores:
