2. 2% CDR will be attached with the bid.
3. If the quoted rates are below more than 10% and additional CDR amounting to Rs. 1000000/= (1.00 Million) must be attached with the bid.
4. Income tax registration/ all previous income tax clearance certificates must be attached with the bid.
5. Cutting over writing and conditional tenders /bids will not be considered.
6. Firms must not be involved in litigation with any Government agency/ Department.
7. A stamp paper must be attached along with the bid stating that firm is not involved in litigation.
8. A complete profile of the firm must be attached showing the execution of all civil, water supply gas etc executed work along with work orders and completion certificate of work from the department/ agencies must be attached of the bid.
9. In case of partnership with the other contractor partnership deed must be attached with the bids.
10. Bank statement of the contractor for the last five years must be attached with the bid.
11. Subletting of the contract to other contractors is not allowed.
12. List of tools and plants must be attached with bid.
