TERMS AND CONDITION FOR CONTRACT OF CAR PARKING IN AYUB TEACHING HOSPITAL, ABBOTTABAD

- 1. The period of contract will be up to 30.06.2019 (for one year) or till completion of next year contract.
- 2. The under mentioned documents are mandatory and bid shall not be accepted without these documents.
 - a. CDR equal to three months quoted rent from schedule bank.
 - b. Valid NTN Certificate. The contractor should be on ATL.
 - c. Bank Statement for the last 3-years.
 - d. Experience in the relevant field in Govt. / Private Teaching Hospital parking not less than 400- bedded hospital duly supported with copy of contract agreement.
 - e. Tender documents receipt.
 - f. An affidavit on judicial stamp paper with regards to that the firm/contractor is not blacklisted from any Govt. department.

Conditions:-

- 1. Minimum monthly rent shall be Rs.120,000/- per month and the highest offer shall be considered successful.
- 2. Tender shall be single stage two envelope basis (technical bid & financial bid)
