
TERMS & CONDITIONS FOR CLEANLINESS OF OUTSIDE OF ATH PREMISES

Mandatory Documents

- 1- CDR Rs. 50000/- must be attached with the tender as bid security.
- 2- Last year income tax return should be on ATL.
- 3- An affidavit on judicial stamp paper with regard to that the firm/contractor is not blacklisted from any Govt. department.
- 4- 3 to 5 years experience in similar nature institutions.

Terms & Conditions

- 1- The contract is valid upto 30-06-2019, or till finalization of new contract (extendable for further 03-months keeping in view the performance).
- 2- Tender shall be single stage two envelope basis (technical bid & financial bid)
- 3- The contractor will bound to provide at-least 15-wokers / employees as per requirement. The minimum wages will be Rs. 15000/- the lowest successful bidder, will be consider.
- 4- The monthly payment will be made to contractor after receipt of performance/ attendance from concerned Incharge.
- 5- Subletting will not be allowed and if found the contract will be cancelled.
- 6- The contractor will submit the daily performance report of their workers to the Administration / i/c Sanitation ATH.
- 7- The Incharge Sanitation ATH to assign the duty on daily basis.
- 8- If the contractor desire to discontinue the contract he will have to serve 01-month advance notice with cogent reason acceptable to competent authority or hospital authority can terminate the contract with one month advance notice.
- 9- In case of breach of any clause of the agreement the competent authority has right to impose fine or cancel the contract.
- 10- In case of any dispute/ conflict raised between both parties (Institution and contractor) the decision of competent authority shall be final.
