**TERMS AND CONDITION FOR CONTRACT OF MESS (DOCTOR FAIMLY
HOSTEL) IN AYUB TEACHING HOSPITAL, ABBOTTABAD**

1. Terms & Conditions can be obtained after deposit of Rs. 1000/- (Non refundable) from Accounts section during working hours.
2. Tender shall be single stage two envelope basis (technical bid & financial bid)
3. The following mandatory documents must be attached with the tender:-
 - a) CDR equal to 3-months rent.
 - b) NTN No. (Active on ATL)
 - c) Tender documents receipt.
 - d) An affidavit on judicial stamp paper with regards to that the firm/contractor is not blacklisted from any Govt. department.
 - e) Bio-data of the worker along with copy of ID cards will have to deposit with the administration by the contractor.
4. The last date for receipt of tender as per Advertisement notice.
5. The period of contract will be up to 30.06.2019 or till completion of next year contract.
6. Minimum monthly Rent shall be Rs.15,100/- excluding utility charges which will be fixed by Maintenance department on actual basis & shall be paid within due date and the highest offer rent shall be considered successful.
7. Monthly rent shall be deposited by 5th of each month in advance failing which 5% penalty shall be imposed for the due month in case of non-deposit of rent for consecutive 3-Months; the contract shall be automatically cancelled.
8. The security of the contractor will be released after completion of contract period.
9. The cleanliness of the Mess & adjacent area will be the responsibility of the contractor, failing which penalty upto 5000/- imposed on contractor.
10. Sub-letting will not be allowed and if found so, the contract will be cancelled by forfeiting the call deposit in favour of the institution.
11. Any type of narcotic/weapon in the hospital premises is strictly prohibited.

12. In case of any violation, the contract shall be terminated without any notice and security will be forfeited and firm also be blacklisted.
13. In case of any conflict arises, the matter shall be resolved through mutual understanding but the decision of the Hospital Director shall be final binding upon both parties.
14. The contractor already working/running the contract must attach clearance certificate from the Accounts Department.
15. It will be the responsibility of the contractor to follow to ensure all the safety measure issue by Assistant Director (Food) for time to time during the contract period otherwise will be dealt according to the rules & regulation by the concerned department.
16. The contractor will be charged as per approved rate list and also display at visible place.
17. All food items must be kept in steel trolley with covered.
18. The contract can be terminated at any time by Hospital Administration with one month notice.
