TERMS AND CONDITION FOR CONTRACT OF MAIN CAR PARKING & MCHC IN AYUB TEACHING HOSPITAL, ABBOTTABAD

- The under mentioned documents are mandatory and bid shall not be accepted without these documents.
 - a. CDR equal to three months quoted rent from schedule bank.
 - b. Valid NTN Certificate. The contractor should be on ATL.
 - c. Bank Statement for the last 3-years showing annual turnover equal to 06-month minimum defined rent.
 - d. 03- Years experience of similar nature in reputed Government / Private Institution. (Documentary evidence to be provided).
 - e. An affidavit on judicial stamp paper duly attested regarding blacklisting.
 - f. Tender Criteria is the part of bidding documents.
 - g. Registration of KPK revenue authority.

Conditions:-

- 1. Technical evaluation will be done on pass, fail basis.
- The period of contract would be up to 30th June 2020. However contract can be terminated at any time by Hospital authority with one month notice or on poor performance it can be terminated at any time without notice. From July 1st 2019 10% increase in rent will be charged.
- 3. Minimum monthly rent shall be Rs.120,000/- per month and the highest offer shall be considered successful.
- 4. Tender shall be single stage two envelope basis (technical bid & financial bid)
- 5. Monthly rent shall be deposited by 5th of each month in advance failing which 5% penalty shall be imposed for the due month in case of non-deposit of rent for consecutive 3-Months; the contract shall be automatically cancelled.
- 6. Cutting/overwriting in the tender will not be acceptable.
- 7. The car parking charges will be Rs. 20/- for all type of vehicles, for motor cycles Rs. 10/-. In case of any overcharging the contract shall be cancelled or fine shall be imposed.
- 8. The Government vehicles, vehicles belonging to doctors and hospital employees will be exempted from any payment.
- 9. The contractor shall be responsible for loss of any vehicle during its stay in the hospital.
- 10. He will work for 24- hours and shall depute additional person to look after the vehicles in Car Parking area for proper parking.

- 16 In case of any conflict raised between the both parties, the decision shall be made on mutual understanding but the decision of hospital director shall be final binding upon the parties.
- 17 The contractor already working/running the contract must attached clearance certificate from the Account Section.
- 19. Number of employees to be deployed by the successful bidder.
- 20. The contract can be terminated at any time by hospital administration with one month notice.
- 21. The contractor will to ensure to control unnecessary parking i.e taxi extra the vehicle so parked four hours will be charged Rs. 20/- and charged Rs. 10/- following per hour.
- 22. Other security equipment i.e Mirror, Metal detector etc will be used for checking of vehicles from entry point.
- The contractor will not go any court of law against the decision of hospital authority.
- 24. The successful bidder will made contract agreement with hospital authority within 10-days after receiving of award letter.
