


**TERMS AND CONDITION FOR CONTRACT OF USED X-RAY CHEMICALS IN  
AYUB TEACHING HOSPITAL, ABBOTTABAD**


1. The following mandatory documents must be attached with the tender:-
  - a) Status of ATL
  - b) Income Tax return
  - c) Sales Tax Registration where applicable.
  - d) Last Year income tax return.
  - e) Las Year sales return where applicable
  - f) Last 03- years Bank statement showing annual turnover equal to 06 months minimum defined rent.
  - g) 03-years audit report Audit reports by external auditor if applicable.
  - h) Registration with respective Govt. department
  - i) Certificate of CDR equal to 03-months quoted rent (as per bidding document) is attached with financial bid.
  - j) Affidavit on stamp paper duly attested regarding black listing.
  - k) 03-years experience of similar nature in a reputed Govt./ Private institution. (Documentary evidence to be provided).
  - l) The tender criteria is a part of bidding documents.
  - m) Registration of KPK revenue authority.
2. Technical evaluation will be done on pass , fail basis.
3. The period of contract would be up to 30<sup>th</sup> June 2020. However contract can be terminated at any time by Hospital authority with one month notice or on poor performance it can be terminated at any time without notice. From July 1<sup>st</sup> 2019 10% increase in rent will be charged.
4. The contractor will have to deposit earnest money equal to 03 months offered amount.
5. Tender shall be single stage two envelope basis (technical bid & financial bid).
6. Subletting will not be allowed and if found the contract will be cancelled.
7. Minimum monthly charges shall be Rs.20,300./- per month and the highest offer shall be considered successful.
8. The chemical shall be collected on monthly basis by 5<sup>th</sup> of each month on payment of offered amount. In case the contractor failed to collect the material by 5<sup>th</sup> of each month, it will be disposed off and contract shall be terminated by forfeited of security/ blacklisting.
9. Sub-letting will not be allowed and if found, so the contract will be cancelled by forfeiting the call deposit in favor of institution.
10. In case of any violation of the contract, the contract shall be terminated without any notice by forfeiture of security will be forfeited and firm shall also be blacklisted for future tendering.
11. The tender shall be received & opened as per Advertisement notice.
12. In case of any conflict raised between both the parties (institution and Contractor) and problem shall be resolved through mutual understanding and the decision of the undersigned will be final.
13. The contractor already working/running the contract must attach clearance certificate from Officer-Incharge contract) and the Account Section.
14. The contract can be terminated at any time by Hospital administration with one month notice.
15. In case of any violation of the contract shall be terminated with out any notice and security will be forfeited and firm will also be blacklisted.
16. The contractor will not be go any court of law against the decision of hospital authority.





17. The successful bidder will make contract agreement with hospital authority within 10-days after receiving of award letter.
18. Fine will be imposed in case of violation of any clause of the contract.
19. Environmental safety measure protection will be adopted.
20. The rate offered in financial bids must be typed and printed, Hand written rates in financial bids will be cancelled.
