Subject: Appointment Order as Charge Nurse

Consequent upon the recommendations of Selection Committee in its meeting held w.e.f 30th Jan to 14th Feb, 2020 you are hereby appointed as Charge Nurse @ Rs.50,000/- per month on the following terms and conditions:

1. Your appointment shall be on contract basis for a term of 03 years against the vacant position and your service shall be governed by the Khyber Pakhtunkhwa MTI Reform Act, 2015 (Amended) Rules 2015 and Medical Teaching Institution Abbottabad Regulation 2019 thereof.
2. You shall be on probation for a period of six months. During probation your services are liable to termination at any time without assigning any reasons. The probationary period may be extended before its completion depending upon your performance/conduct. In case no letter of confirmation is issued, the probation period shall be considered as extended.
3. Other normal rules/regulations being implemented in the ATH would equally apply to your service.
4. If you want to resign from service you have to give one month notice in advance or deposit one month salary in lieu of advance notice. Similarly, your services may be terminated on one month notice after probation period.
5. During your probation period you shall not be entitled to long leave, ex-Pakistan leave.
6. Verification of your qualification, character and antecedent will be carried out at your own expenses through the appropriate channels. If found unsatisfactory your services shall be terminated with immediate effect.
7. You shall not associate with any of association and will not go on strike. In that case your services will be terminated at once without any notice.
