Terms and Conditions

- 1. The period of contract would be up 31th December 2021 or till the finalization of next tender.
- 2. The terms and conditions mentioned in the above advertisement notice and technical evaluation criteria are part of bidding documents
- 3. The contractor must follow all the general terms and conditions as prescribed by KPPRA.
- 4. The bidding documents are available on our official website.
- 5. Tender shall be single stage two envelope basis and the envelopes must bear TENDER for Cath Lab Pharmacy shop. One envelope marked as Technical Bid and other Envelope marked as Financial Bid.
- 6. The bidder shall submit the financial bid in words and in figures on the letter head duly signed and stamped, Any cutting ,hand writing on tender will be rejected.
- 7. The KPPRA Act/standard bidding documents is a part of the bidding documents and contract agreement.
- 8. The tender documents can be obtained and submitted in the procurement cell of ATH after deposit of tender fees.
- 9. Ambiguous and overwritten tender shall not be accepted.
- 10. In case of false information, the tender will be rejected and CDR of the firm will be forfeited.
- 11. The minimum rent of the Cath Lab pharmacy shop will be Rs. 100,000 per month
- 12. The highest bidder amongst technically qualified bidder shall be declared as successful.
- 13. Electricity charges will be paid by the contractor on actual consumption for which a separate meter will be installed. The contractor will pay the electricity charges within 05 days after receipt of bill from the Engineering and Maintenance Department.
- 14. The monthly rent shall be paid by 5th of each month. In case of nonpayment a total of 5 % penalty of the total monthly rent shall be imposed per day incase of non-payment of the rent for more than one month after the due date, the contract will be canceled and CDR will be forfeited.
- 15. Ten percent (10%) increase on rent shall be paid by the contractor on completion of one year till finalization of next financial year tender.
- 16. The store under this agreement is required to be opened 24/7/365 days without any break.
- 17. Successful bidder shall start computerized inventory /bill system.
- 18. The staff must wear proper uniform.

- 19. The earnest money may be confiscated totally in favor the institution if there is a breach of any clause of the agreement.
- 20. In case of any dispute, the decision of Hospital Director shall be final and the contractor shall not be allowed to file any case in the court of law.
- 21. The Hospital Director has the right to shift or close the shop at any time on one month prior notice.
- 22. The contractor will submit CDR equal to three months rent with the tender which shall be refunded on completion of contract and clearance of all dues.
- 23. The contractor shall provide all items required for cath lab.
- 24. The Cath lab pharmacy shop at the end of contract or earlier will return all fixtures and fitting in good condition as received. Temperature condition must be followed as per labeled instructions.
- 25. Best storage practice shall be observed.
- 26. The Cath Lab Pharmacy shop shall be run as per DRAP Act and Drug Act 1976.
- 27. The contractor shall provide legal warranty of all the items as per Drug/DRAP Act.
- 28. The Cath Lab pharmacy shop must ensure all the items which will be provided by the end user for inventory.
- 29. The contractor must ensure cleanliness of shop and its front area.
- 30. The contractor will retain the invoices of purchased items and will provide it to the authority if required.
- 31. The rate of the items must be compatible with the market rate and contractor should give Surety Bond on stamp paper of Rs 500/- for the uniform rates.
