Sealed and postal tenders are invited for the following to Ayub Teaching Hospital Abbottabad for the Year 2020-21 and or till the finalization of next year tender from the eligible firms as per bidding documents.

- 1. Active Status on ATL
- 2. NTN Registration.
- 3. GST Registration.
- 4. Last year Income Tax.
- 5. Last year sale tax return.
- 6. Last three years Bank Statement.
- 7. Registration With KPRA (Khyber Pakhtunkhwa Revenue Authority) if applicable.
- 8. Affidavit on stamp paper duly attested regarding not blacklisting by any Govt /Semi Govt: departments
- 9. 2% bid security in shape of Call Deposit against quoted calculated amount is attached with the bid.
- 10. Three years Market experience (certificate must be attached)
- 11. Rate Quoted must be in printed form: hand written quoted rate will be rejected.
- 12. Tender will be received and open as per advertisement notice.
- 13. Tender will be considered according to KPPRA rules.
- 14. The KPPRA standard bidding documents/ General Condition of the contract are part of this bidding Documents
- 15. Tender will be single stage single envelop basis.
- 16. The tender envelops must be sealed and Marked as "Name of Tender" which shall be addressed to Hospital Director Ayub Teaching Hospital.
- 17. The bidding documents fee Rs. 1500/- is non-refundable.
- 18. Incomplete tender will not be accepted.
- 19. Conditional tender will not be accepted.
- 20. The price must be quoted as per Tender list.
- 21. The only one price must be quoted against each item.
- 22. Is the supply is found inferior to by the purchase/inspection committee, the consignment will be rejected.

- 23. The sample laying in article store the interested bidders can visit there during working hours for checking and information regarding samples.
- 24. The payment will be made after receipt/acceptance of goods in good condition (as per sample) No advance payments will be made under no circumstance, No substandard material will be accepted.
- 25. The competent authority can cancel the tender as per KPPRA rules.
- 26. The tender will be rejected straight away without assigning any reason if the firms declared black listed by any Govt./Semi govt. department/ agencies etc.
- 27. If the performance of any item and product fails to meet the contract specification then the same shall be replaced by suppler free cost during the term of guarantee period.
- 28. All prices mentioned in the financial proposal shall be in Pak Rupees (PKR). Item and product fails to meet the contract specification then the same shall be replace by the supplier free of cost during the term of the warranty/guarantee period.
- 29. The quoted rates should be inclusive of all applicable Govt taxes and any additional charges the hospital authority shall not be responsible to pay for transportation/installation/commissioning etc.
