TERMS AND CONDITION FOR CONTRACT OF USED X-RAY CHEMICALS IN AYUB TEACHING HOSPITAL, ABBOTTABAD

- 1. The following mandatory documents must be attached with the tender:
 - a) Status of ATL
 - b) Income Tax return
 - c) Last Year income tax return.
 - d) Last Year sales return where applicable
 - e) Last 03- years Bank statement showing 0.5 million closing balance.
 - f) CDR equal to 03-months quoted rent attached.
 - g) 03-years experience of similar nature in a reputed Govt./ Private institution. (Documentary evidence to be provided).
- 2.
