

1. Your appointment is on contract basis and shall be regulated as per uniform contract policy under the Contract Pay Scale (CPS) and Contributory Provident Fund (CPF) Regulations 2020 or any related amendments and shall be governed by the Khyber Pakhtunkhwa MTI Reform Act 2015, MTI Rules and Medical Teaching Institution Abbottabad Regulations, 2016 or any related amendments thereof.
2. You shall be paid salary in CPS-04 @ Rs.26,000 - 44,200 along with other usual allowances and other benefits as admissible to the institutional employees under the CPS regulations 2020.
3. You shall be allowed Annual Increment, Contributory Provident Fund (CPF) gratuity and medical treatment/reimbursements as per institutional policy.
4. You shall report to the Nursing Director MTI, ATH.
5. You shall be on probation for a period of one year and your services are liable to be terminated at any time without assigning any reasons particularly in case of unsatisfactory report or absence from duty. The probationary period may be extended before its completion depending upon your performance/conduct.



During your probation period you shall not be granted any long leave, Ex-Pakistan leave or the training leave and you shall be entitled for leaves as per MTI, ATH, Abbottabad leave rules and regulations.

7. You shall not be allowed employment outside the institution during the employment with this institution.
8. Your appointment shall be subject to medical fitness, verification of qualification, report of verification of character and antecedent through appropriate channels. If found otherwise, will be treated accordingly.
9. You shall not associate with any unrecognized/illegal employee association and will not go on strike.
10. You shall ensure attendance through biometric system.
11. Your service may be terminated by the MTI, ATH by giving one month advance notice or one month salary in lieu of the notice by the competent authority.
12. If you wish to resign from the service you have to serve one month notice period or deposit one month salary in lieu of advance notice. Failure to do so will result in termination of service.
13. You shall be entitled for reimbursements of travel expenses as per MTI, ATH, Abbottabad rules and regulations.
14. No TA/DA shall be allowed for joining the duty.
15. You should report to the institution for duty within 15 days from the issue of this order alongwith Medical Fitness certificate confirmed by the Standing Medical Board, ATH before joining.
16. In case you fail to report for duty within 15 days of the issue of this order, the appointment order shall stand cancelled.
17. You shall perform your duties in any of three shifts (Morning/Evening/Night), under the administrative control of Nursing Director.
18. You are bound to perform duties as per job descriptions.
