


## TERMS AND CONDITIONS:-

1. The firm must be registered with Pakistan Engineering Council in category C-4 or above category having relevant codes.
2. The Firm must be registered with Govt. of KP. The enlistment certificate must be attached with the bid along fee deposit receipt of current year.
3. Rs. 1000000/= CDR must be attached with the bid.
4. If the quoted rates are below more than 15% and additional CDR amounting to Rs. 1000000/= (1.00 Million) must be attached with the bid.
5. Income tax registration / previous income tax clearance certificates must be attached with the bid and firm must be active on ATL.
6. Cutting / over writing and conditional tenders / bids will not be considered.
7. Firms must not be involved in litigation with any Government agency /department.
8. A stamp paper must be attached along with the bid stating that firm is not involved in litigation against any department and also not blacklisted by any Department.
9. A complete profile of the firm must be attached showing the execution of all civil, water supplies, gas, electrical work, mechanical works etc executed work along with work order and completion certificates of work from the department/agencies must be attached along with the bid.
10. In case of partnership with the other contractor partnership deed must be attached with the bids.
11. Bank statement of the contractor for the last three years must be attached with the bid.
12. Subletting of the contract to other contractors is not allowed.
13. List of tools and plants must be attached with bid.
14. Technical staff and skilled labor as per requirement must be present at institute along with necessary materials for executions of works on emergency basis, after signing the agreement. Focal person will remain in the institute and will not leave the site without permission of client.
15. The firm must be registered with KP revenue authority.
16. The contractor quoting their bids more than 15% below shall submit at the time of work order of work an additional security to the extent of their bid / rates more than 15% below of the Engineer Estimate in the form of percentage when Rs. 1.00 Million CDR already attached with Tender is finished against the work orders.
17. Hand written quoted rates will not be acceptable.
18. The tender will be on single stage single envelope basis as per KPPRA Rules.
19. All the applicable taxes will be deducted from the bills of the contractor as per government prevailing rules.
20. The tender will be opened as per advertisement.
21. Any false information if given in the profile/bid will lead termination of contract and all deposited fees/CDRs will be forfeited.
