- 1. The following mandatory documents must be attached with the tender:
 - i) CDR equal to 03-months quoted rent attached.
 - ii) NTN registration
 - iii). ALT
 - iii) Tender Document Receipt
 - iv) An Affidavit on judicial stamp paper with regards to that the firm/contractor is not blacklisted from any Govt. department.
- Minimum monthly rent shall be Rs. 107,175/- per month (including utility charges) and the highest offer of the bids rent shall be considered successful.
