

AGREEMENT DEED (for successful bidder)

This agreement is made at Ayub Teaching Hospital on _____ between successful bidder through

_____ CNIC No. _____ Designation _____, Official Address _____

_____, hereinafter referred as 1st Party, which expression shall unless repugnant to the context mean and include this heirs, executors, administrators, successors, and assigns.

AND

The Hospital Director Ayub Teaching Hospital MTI, Abbottabad (here in after referred as 2nd Party which expression shall unless repugnant to the context mean and include its successors-in-interest and assigns.

Whereas 2nd Party is a Prominence Company Manufacturer of Medical Gases and in consequence of tender notice and quotation submitted by the 2nd Party which was duly compared and negotiated with the purchase committee is willing to supply Medical Gases as mentioned below and the 1st Party being the competent authority is agreed to accept the Medical Gases on the following terms and condition: -

1. That the 2nd Party shall abide by the order of 1st party and authorities under whom it may from time to time be placed by the 1st party or supervision of supply.
2. In continuation of supply (Medical Gases) made by the 2nd Party under the agreement the 1st party shall on the representation of the bills pay as per tender documents rates accepted by the 1st party.
3. The rates accepted shall be valid till 30.06.2024 which shall be extendable upon Mutual Understanding of both the parties. In case of any ban on institute for new-tendering/New issuing of letter of award from Provincial Government, 2nd party will not terminate supply Medical Gases to hospital in best interest of Patient. In such case if happen or tried to black mail hospital, 2nd party will be black listed and security will be forfeited.
4. The 2nd party shall be responsible for the supply throughout the mentioned period without any break. In case of any fault/service/repair in the plant required, the 2nd party will inform the 1st party in advance and also arrange Liquid Oxygen from alternate source for hospital.
5. Liquid Medical Oxygen (VIE TANK 15000 lit Qty O2Nos) with evaporating coil and upstream system and Telemetry System installed by the 2nd party would remain the property of the 2nd party. At present Liquid Oxygen (VIE TANK 15000 lit qty O2Nos) with evaporating coil and upstream system installed at Ayub Teaching Hospital Abbottabad will be returned to the 2nd Party i.e. (_____) on cancellation of contract agreement by either party giving one-month prior notice.
6. The 2nd party shall be responsible for the service of Liquid Oxygen (VIE TANKS) with complete

7. on yearly basis and 2nd party shall be responsible for security and safety of VIE TANK and accessories.

The bills will be paid by 1st party to the 2nd party at an early date within Fifteen Days on submission of bills.

8. The 2nd party will refill the minimum 100 Cylinder or as per requirement of the hospital on daily basis and the 1st party staff will be responsible to arrange the empty cylinders stock for refilling.

9. Telemetry System installed by 2nd party and will be monitored 24/7, however its monitoring access will also be provided to Hospital Oxygen Plant Engineer, as per their demand and provision of required Monitors and network system in required place.

10. The 2nd Party will be responsible to fill the VIE Tank before level reaches to 50%, and 1st Party will be responsible to monitor the VIE Tank Level 24/7 and will inform the same to 1st party timely.

11. In case of any shut down or maintenance / trouble shooting required in the VIE Tank, Successful bidder will carry out the repair work and tanker will be arranged as back up supply, however compressed cylinder must be arranged /available for any emergency in the Hospital.

12. Purity Certificate must be provided with quaterly supply of Liquid Medical Oxygen.

13. Operational, Maintenance and safety training on VIE Tank and Cylinders Handling will be provided to ATH Staff as and when required basis throughout the contract period.

14. The prices of Compressed Gases / Liquid Oxygen are inclusive of Sales Tax.

15. The 2nd party shall indemnify the 1st party in case of any accident occurred due to shortage of Medical Gases and will arrange liquid oxygen from alternate source to hospital.

AS medical Gas is an essential item, please ask competent authority for approval of tender along selection criteria, Terms & condition. Keeping in view the Health Department Notification of Stoppage of Ban items vide letter Number SOH/MTIs/Gen/2023 on dated 24th May.2023. It is also pertinent to mention that Ghani Chemical Limited Supply will be terminated as per their letter No. GCIL/ATH/0806 on Dated; 08/06/2023.
