Sealed and postal tenders are invited for the following to Ayub Teaching Hospital Abbottabad for the Year 2023-24 and or till the finalization of next year tender from the eligible firms as per bidding documents.

- 1. Active Status on ATL
- 2. NTN Registration.
- 3. Last year Income Tax.
- 4. Last three years Bank Statement.
- 5. Registration with KPRA (Khyber Pakhtunkhwa Revenue Authority).
- 6. Affidavit on stamp paper duly attested regarding not blacklisting and not in litigation with any Govt /Semi Govt: departments
- 7. The firm must be registered with Pakistan Engineering Council in category C-4 or above category having relevant codes (Electrical codes).
- 8. The Firm must be licensed by the Provincial Board of licensing Energy & Power Department Peshawar, Government of Khyber Pakhtunkhwa. The valid licensed must be attached with the bid
- 9. Rs. 1,000,000/= CDR must be attached with the bid.
- 10.If the quoted rates are below more than 10%, an additional CDR amounting to Rs. 1,000,000/= (1.00 Million) must be attached with the bid.
- 11. The contractor quoting their bids more than 10% upto 20% below shall submit at the time of each work order of work an additional security of 10% of the Engineer Estimate in the form of percentage when Rs. 1.00 Million CDR already attached with Tender is finished against the work orders.
- 12. The contractor quoting their bids more than 20% below shall submit at the time of work order of work an additional security to the extent of their bid / rates below of the Engineer Estimate in the form of percentage. When Rs. 1.00 Million CDR already attached with Tender is finished against the work orders.
- 13.Income tax registration / previous income tax clearance certificates must be attached with the bid and firm must be active on ATL.
- 14. Cutting / over writing and conditional tenders / bids will not be considered.
- 15. Firms must not be involved in litigation with any Government agency /department.
- 16.A stamp paper must be attached along with the bid stating that firm is not involved in litigation against any department and also not blacklisted by any Department.
- 17.A complete profile of the firm must be attached showing the execution of all Electrical executed work along with work order and completion certificates of work from the department/agencies must be attached along with the bid.
- 18. In case of partnership with the other contractor partnership deed must be attached with the bids.
- 19. Bank statement of the contractor for the last three years must be attached with the bid.
- 20. Subletting of the contract to other contractors is not allowed.
- 21. List of tools and plants must be attached with bid.
- 22. Technical staff and skilled labor as per requirement must be present at institute along with necessary materials for executions of works on emergency basis, after signing the agreement. Focal person will remain in the institute and will not leave the site without permission of client.
- 23. The firm must be registered with KP revenue authority.
- 24. Hand written quoted rates will not be acceptable.
- 25. The tender will be on single stage single envelope basis as per KPPRA Rules.
- 26. All the applicable taxes will be deducted from the bills of the contractor as per government prevailing rules.
- 27. The tender will be opened as per advertisement.
